SOFTWARE LICENSE AGREEMENT

This Software License Agreement ("Agreement") is made between Dark Blue Duck ("Distributor") and yourself ("Licensee").

Distributor licenses to users the software program marketed under the name SAVE PAPER DOCS (the "Software").

Licensee desires to utilize a copy of the Software.

NOW, THEREFORE, in consideration of the mutual promises set forth herein, Distributor and Licensee agree as follows:

1. License.

Distributor hereby grants to Licensee nonexclusive, limited license to use the Software as set forth in this Agreement.

2. Term.

License Grant - Length of Term. The provisions of this licensing agreement are effective unless terminated. FOLLOWING THE EXPIRATION OF THE APPLICABLE MAINTENANCE TERM, YOU MAY NO LONGER USE THE SOFTWARE.

3. Restrictions.

Licensee shall not modify, copy, duplicate, reproduce, license or sublicense the Software, or transfer or convey the Software or any right in the Software to anyone else without the prior

written consent of Distributor; provided that Licensee may make copies of the Software for backup or archival purposes.

Licensee shall not modify the Software, incorporate the Software in whole or in part in any other product or create derivative works based on all or part of the Software. Licensee shall not remove any copyright, trademark, proprietary rights, disclaimer or warning notice included on or embedded in any part of the Software. Licensee shall not use the Software in connection with a service bureau, time sharing or fee for service arrangement with third parties.

4. Fee.

In consideration for the grant of the license and the use of the Software, Licensee agrees to pay Distributor the sum of the license fee as published on the Distributor's web site price list and an annual software maintenance fee as published on the Distributor's web site price list.

5. Warranty of Title.

Distributor hereby represents and warrants to Licensee that Distributor is the owner of the Software or otherwise has the right to grant to Licensee the rights set forth in this Agreement. In the event any breach or threatened breach of the foregoing representation and warranty, Licensee's sole remedy shall be to require Distributor or to either: i) procure, at Distributor's expense, the right to use the Software, ii) replace the Software or any part thereof that is in breach and replace it with Software of comparable functionality that does not cause any breach, or iii) refund to Licensee the full amount of the license fee upon the return of the Software and all copies thereof to Distributor.

6. Warranty of Functionality.

For a period of 30 days following delivery of the Software to Licensee (the "Warranty Period"),

Distributor warrants that the Software shall perform in all material respects according to the Distributor's specifications concerning the Software when used with the appropriate computer equipment. In the event of any breach or alleged breach of this warranty, Licensee shall promptly notify Distributor and return the Software to Distributor at Licensee's expense. Licensee's sole remedy shall be that Distributor shall correct the Software so that it operates according to the warranty. This warranty shall not apply to the Software if modified by anyone or if used improperly or on an operating environment not approved by Licensor.

7. Annual Software Maintenance.

The Licensee shall pay, in advance, an annual software maintenance fee. Payment of the annual software maintenance fee must be made no later than the anniversary of the license

issue date. Payment for the first term is included in the initial purchase price. The applicable fees are stated on the Distributor's web site price. If the software maintenance fee is not provided or provided late and the Licensee, thereafter, desires to reinstate maintenance, the Licensee shall pay a reinstatement fee. The reinstatement into software maintenance is subject to possible separate software upgrade costs and an administration fee.

8. Payment.

Payment of the license fee shall be made before delivery of the software license key. Payment of any other amount owed by Licensee to Distributor will be provided in advance.

9. Taxes.

In addition to all other amounts due hereunder, Licensee shall also pay to Distributor, or reimburse Distributor as appropriate, all amounts due for property tax on the Software and for sales, use, excise taxes or other taxes which are measured directly by payments made by Licensee to Distributor. In no event shall Licensee be obligated to pay any tax paid on the income of Distributor or paid for Distributor's privilege of doing business.

10. Warranty Disclaimer.

DISTRIBUTOR'S WARRANTIES SET FORTH IN THIS AGREEMENT ARE EXCLUSIVE AND ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

11. Limitation of Liability.

Distributor shall not be responsible for, and shall not pay, any amount of incidental, consequential or other indirect damages, whether based on lost revenue or otherwise, regardless of whether Distributor was advised of the possibility of such losses in advance. In no event shall Distributor's liability hereunder exceed the amount of license fees paid by Licensee, regardless of whether Licensee's claim is based on contract, tort, strict liability, product liability or otherwise.

12. Notice.

Any notice required by this Agreement or given in connection with it, shall be in writing and shall be given to the appropriate party by personal delivery or by certified mail, postage prepaid, or recognized overnight delivery services.

13. Governing Law.

The laws of England and Wales will govern the interpretation and enforcement of these Terms and Conditions.

14. No Assignment.

Neither this Agreement nor any interest in this Agreement may be assigned by Licensee without the prior express written approval of Distributor. Provided that a corporate successor resulting from a merger or consolidation of the Licensee and another organisation will retain rights granted under this agreement.

15. Source code escrow.

If the Distributor is unable to provide maintenance of the Software because of bankruptcy the Licensee may be provided with a copy of the Software source code. The Distributor shall not be responsible for, and shall not pay, any Escrow Agent fees.

16. Final Agreement.

This Agreement terminates and supersedes all prior understandings or agreements on the subject matter hereof. This Agreement may be modified only by a further writing that is duly executed by both parties.

17. Severability.

If any term of this Agreement is held by a court of competent jurisdiction to be invalid or unenforceable, then this Agreement, including all of the remaining terms, will remain in full force and effect as if such invalid or unenforceable term had never been included.
